

ARCHITECTURAL FORMS

Paradise Valley Campground has many Architectural Forms and related information sheets. We are including two here; Inspection agreement and the general building or improvements Request Form.

At this time there are eight forms listed by the PVC Committee responsible for granting related permits for construction and improvements to a lot. These forms cover such topics as:

- Variances
- Roof extensions over porches and decks
- Bringing a wide (12) Park Model to PVC
- Inspection Agreement for your Lot **(See Page 2 this document)**
- General construction / improvement request **(See Page 3 this document)**
- Building information you must provide
- Guidelines for 8x10 sheds
- Screening porches

These forms are only for the PVC HOA. Additional requirements exist in/for White County that requires separate County Permits or Variances for significant improvement.

PVC Forms, as above, often change. While we are providing two forms in this season of the several you might require, we direct you to Architectural Committee members or this website (www.paradisevalleycamp.com) for the others, and or a new topic (?) that might apply to what you want to do on your Lot.
