#### LONG RANGE PLANNING COMMITTEE

Ken Kilgo, Chairman presented preliminary drawings for renovation to the pavilion. This is the First Phase. The Second Phase will complete the drawings that can be presented to a contractor for a bid. These drawings are posted on the board for all to see.

## **ACTIVITIES GROUP**

Barbara Tidwell, Chairperson stated that a bus trip has been planned for a visit to Cherokee, NC. The bus will seat 56 people, only 36 have signed up to go, so there is room left for more passengers. The group has something special planned for Labor Day.

### UNFINISHED BUSINESS None

#### **NEW BUSINESS**

1-The Activities Group requested the use of the pavilion for a craft sale to be held on 25 August 2007. Motion made by Buck Tidwell to approve request, seconded by Bill Dotson. Request approved by a vote of 6-0

- 2-A request has been received for permission to build fences on perimeter lots. Buck Tidwell stated that a variance to the covenants must first be approved. Motion made by Buck Tidwell to issue a variance to the covenants to erect a perimeter fence, seconded by Bill Dotson. Motion carried to issue variance by a vote of 6-0. Motion made by Buck Tidwell to approve guidelines for perimeter fences as submitted by Architectural Committee. Motion seconded by Jerry Higgins. Motion approved by a vote of 5-1
- 3-Paint pool house, laundry room, well house and offices using a redwood natural tone paint. The cost involved will be \$2,542.01 for painting and minor repairs. The bid selected was submitted by John Adams. Motion made by Buck Tidwell to accept bid by John Adams, seconded by Nick Coman. Motion carried by a vote of 6-0

- 4-A copy machine is needed for the Association Office. The cost for leasing a copier would be \$90.00 per month and would allow 12,000 copies a year. The contract is for a period of three years. This cost also includes maintenance and up-keep. Four hundred dollars has just been paid to renew the old contract. This money will be refunded by the Printing Co. Motion made by Nick Coman to accept contract, seconded by John Gardner. Motion approved by a vote of 6-0
- 5- Nan Hohne was appointed to head the nominating committee for year 2008.

The floor was then opened to the membership.

- 1-A request was made by Gene Ewert to have excess to the kitchen when the card group met and played cards.
- 2-Pat Watkins stated that the kitchen should be open and be available for people who might have a handicap.
- 3-Mildred Pelt said the kitchen should be open during the day when the craft group is painting to allow them to wash their hands and clean up when they were finished. A hand vote of the membership was conducted. 19 wanted the kitchen open and 14 wanted it remained closed. The Board of Directors discussed this request thoroughly. John Gardner made a motion to keep kitchen locked, seconded by Buck Tidwell. Motion carried by a vote of 6-0
- 4- Gene Ewert asked Bill Dotson, Treasurer if an audit was conducted before he took over the books. Bill Dotson said an audit had just been completed.
- 5- Beverly Sundin said the condition of some of the roads were too narrow at different places. She said that a neighbor had recently taken a fall because of the road conditions. Buck Tidwell said the problem was now being addressed.
- 6- Mildred Pelt said that the guilt was now finished for all to see.

Buck Tidwell made a motion to adjourn the meeting, seconded by John Gardner. Motion approved by a vote of 6-0
